- OGN in use

- OGN tracking in use – **no start time reporting**

- For Lowcrop mobile application – at Scoring office
- In case of glider damage – note in Lowcrop
- Announce to CD or Deputy CD
- Update Lowcrop when arriving to the airfield after outlanding.

- Please send your IGC file via website or email ([igc@egc2017.cz](mailto:igc@egc2017.cz)) intime according to LP.
- Follow the IGC processing status – Pilot Status at Website
- **Fill headers of IGC files with correct values for all FR (pilot, a/c type, a/c registration, SN).**
- FR change must be announced to CD (according to SC3 A).
- Turbo's and Self-Launches must submit at least one file from FR during official trainings. ENL check.
- Others must submit at least one file from all used FR during Official Trainings. No need to fly.

- Grid order of classes – mixed – depending on weather
